

Don Antonio Glamping Village consolidates its commitment to **respecting nature and the environment** by joining the EcoWorldHotel program.

After obtaining LEGAMBIENTE certifications, ISO 9001 for quality business management and ISO 14001 for environmental management and accountability, in 2021 Don Antonio will receive the Seal of Quality from the **independent third-party DNV GL**, among the world's leading certifying bodies.

Eco-certification follows precise and detailed guidelines that lead to sustainable facilities being ranked in Eco-Leaves, from 1 to 5. All eco-certified facilities implement environmentally friendly practices by meeting 15 mandatory minimum requirements, which we list below and kindly ask you to view:

- 1) Don Antonio Glamping Village identifies **the EcoWorldHotel Certification Manager as Antonio Delli Compagni**, who is responsible for enforcing all procedures related to the certification of the accommodation. The Certification Manager communicates to ownership/management regarding the accommodation's sustainability performance;
- 2) Upon arrival, the staff informs guests about **the environmental policy applied** and the EcoWorldHotel environmental quality label membership. In particular, it arranges the information prominently on bulletin boards at the entrance and in common areas. The window sticker bearing the number of 1 eco-leaf achieved and the certificate issued by DNV GL Business Assurance Italia s.r.l. are displayed on the glass door of the reception area;
- 3) The accommodation uses more than **50 percent certified paper for stationery uses**;
- 4) The accommodation facility **uses more than 90 percent certified paper for hygienic use**;
- 5) At least one **personal hygiene product**, available to the facility's clients, has **an eco-certification**;
- 6) **Customers and staff are adequately informed** about **the public transportation services** available in the area and the possibility of using other environmentally suitable means of transportation (bicycle) by posting schedules and information on **the free MyDonAntonio App**;
- 7) More than 60 percent of the light bulbs installed in the rooms are LED type;
- 8) **All faucets in the rooms have a water flow of no more than 12 l/min**;
- 9) Maintenance and repair work on boilers and air conditioners shall be carried out by qualified professionals, at least once a year, and more frequently if required by law or if necessary, according to EU standards and applicable national/regional standards, or according to the manufacturer's instructions;
- 10) Through appropriate written notice, **the guest is made responsible for the frequency of washing towels and towels**. Hanging under the television in all rooms is such a notice, which we ask you to read;
- 11) The accommodation facility applies the regulations for the **separate collection** of recyclable fractions in force in the municipality. The service staff carries out the separate collection of waste produced by the facility in order to promote reuse and recycling as much as possible. Responsibility for the correct application lies with the tourist accommodation facility that certifies itself, as well as compliance with all applicable legal requirements of a mandatory nature (such as directives, laws, regulations) related to the conduct of its business;
- 12) Inside the facility there is a **binder for exhausted batteries** at the reception desk;
- 13) At least two **certified cleaning products** shall be used, and personnel shall be instructed in the proper use of the quantities of the products so that they never exceed the doses recommended in the instructions;
- 14) The facility has more than 10 breakfast items available **from local producers** located within 150 km of the accommodation;
- 15) The facility has more than 10 breakfast items available that hold **certifications** proving **organic production**.
